1 The bill as proposed to be amended is reprinted as follows:

2 Section 1. Title 15, chapter 1, article 1, Arizona Revised

3 Statutes, is amended by adding section 15-120.05, to read:

4 15-120.05. Crimes against children: parent training: definition

5 A. THE DEPARTMENT OF EDUCATION SHALL DEVELOP AND MAINTAIN A WEBPAGE FOR PARENT TRAINING PROGRAMS AND RESOURCES PURSUANT TO THIS SECTION THAT

6 INCLUDES ALL OF THE FOLLOWING:

7 1. AT LEAST ONE TRAINING PROGRAM THAT IS PROVIDED FREE OF CHARGE AND THAT INCLUDES INSTRUCTION ON BOTH CHILD SEX TRAFFICKING AND INTERNET CRIMES AGAINST CHILDREN. IF AVAILABLE, THE DEPARTMENT OF EDUCATION MAY USE A TRAINING PROGRAM THAT IS PROVIDED FREE OF CHARGE BY THE ARIZONA DEPARTMENT OF HOMELAND SECURITY FOR THE PURPOSES OF THIS PARAGRAPH.

8 2. EDUCATIONAL MATERIALS AND RESOURCES RELATED TO PREVENTING CHILD SEX TRAFFICKING AND INTERNET CRIMES AGAINST CHILDREN.

9 [3. INFORMATION IN A PRINTABLE FORMAT FOR PARENTS AND GUARDIANS WHO

10 DO NOT HAVE ACCESS TO THE INTERNET. INFORMATION PROVIDED PURSUANT TO THIS

11 PARAGRAPH SHALL INCLUDE INFORMATION ABOUT HOW PARENTS AND GUARDIANS MAY

12 ACCESS TRAINING IN ALTERNATIVE FORMATS THROUGH PUBLIC SCHOOLS, INCLUDING

13 CONTACT INFORMATION.]

14 B. [ON THE REQUEST OF A PARENT OR GUARDIAN.] EACH SCHOOL SHALL

15 PROVIDE [BOTH OF THE FOLLOWING.]

16 [1.] INFORMATION [IN A HARD COPY FORMAT] ABOUT THE TRAINING PROGRAM

17 AND AVAILABLE RESOURCES DESCRIBED IN SUBSECTION A OF THIS SECTION TO

18 [EACH] [THE] PARENT OR GUARDIAN OF A STUDENT AT THE [BEGINNING OF EACH]

19 SCHOOL YEAR OR, IF APPLICABLE, WHEN THE STUDENT TRANSFERS TO THE SCHOOL.

20 THE INFORMATION PROVIDED PURSUANT TO THIS PARAGRAPH SHALL INCLUDE]

1 SCHOOL. THE INFORMATION PROVIDED TO THE PARENT OR GUARDIAN SHALL INCLUDE
2 ALL OF THE FOLLOWING:

3 [~~(a)~~] [1.] A STATEMENT THAT, TO ENHANCE CHILD SAFETY AWARENESS, THE
4 PARENT OR GUARDIAN IS STRONGLY ENCOURAGED TO COMPLETE THE TRAINING PROGRAM
5 AT LEAST ONCE EACH YEAR.

6 [~~(b)~~] [2.] A DESCRIPTION OF THE TRAINING PROGRAM THAT IS PROVIDED
7 FREE OF CHARGE PURSUANT TO SUBSECTION A, PARAGRAPH 1 OF THIS SECTION,
8 INCLUDING INFORMATION ABOUT HOW TO ACCESS THE TRAINING PROGRAM.

9 [~~(c)~~] INFORMATION ABOUT ONE OR MORE TRAINING PROGRAMS THAT THE
10 SCHOOL PROVIDES IN AN ALTERNATIVE FORMAT PURSUANT TO PARAGRAPH 2 OF THIS
11 SUBSECTION FOR PARENTS AND GUARDIANS WHO DO NOT HAVE ACCESS TO THE
12 INTERNET.

13 2. A TRAINING PROGRAM AND RELATED MATERIALS AS PRESCRIBED BY
14 SUBSECTION A, PARAGRAPHS 1 AND 2 OF THIS SECTION IN THE BEST FEASIBLE
15 ALTERNATIVE FORMAT, AS DETERMINED BY THE SCHOOL, FOR ANY PARENT OR
16 GUARDIAN WHO DOES NOT HAVE ACCESS TO THE INTERNET.]

17 [C. THE INFORMATION PRESCRIBED BY SUBSECTION B, PARAGRAPHS 1 AND 2
18 OF THIS SECTION MAY BE PROVIDED TO EACH PARENT OR GUARDIAN OF A STUDENT AT
19 THE SCHOOL AT THE BEGINNING OF EACH SCHOOL YEAR OR, IF APPLICABLE, WHEN
20 THE STUDENT TRANSFERS TO THE SCHOOL.]

21 [C.] [D.] FOR THE PURPOSES OF THIS SECTION, "SCHOOL" MEANS A SCHOOL
22 DISTRICT OR CHARTER SCHOOL IN THIS STATE THAT PROVIDES INSTRUCTION TO
23 STUDENTS IN KINDERGARTEN PROGRAMS OR ANY OF GRADES ONE THROUGH EIGHT.

24 Enroll and engross to conform

25 Amend title to conform
