1 The bill as proposed to be amended is reprinted as follows:
2 Section 1. Title 28, chapter 3, article 3, Arizona Revised
3 Statutes, is amended by adding section 28-654, to read:
4 28-654. Signs; lane use; requirements
5 A. THE DEPARTMENT AND EACH LOCAL AUTHORITY SHALL PLACE SIGNS ON A
6 HIGHWAY WITH TWO [~~OR MORE~~] LANES FOR USE BY MOTOR VEHICLES TRAVELING IN
7 THE SAME DIRECTION THAT DIRECT SLOWER TRAFFIC TO TRAVEL IN A LANE OTHER
8 THAN THE FARTHEST LEFT LANE.
9 B. THE SIGN MUST:
10 1. READ "LEFT LANE FOR PASSING ONLY, SLOW TRAFFIC KEEP
11 RIGHT." [THE SIGN SHALL BE FORTY-EIGHT INCHES IN HEIGHT AND FORTY-EIGHT
12 INCHES IN WIDTH.]
13 2. [EITHER:
14 (a)] BE ACCCOMPANIED BY A SMALLER SIGN THAT READS "\$500 FINE"
15 PURSUANT TO THE CIVIL PENALTY IMPOSED IN SECTION 28-721.
16 [(b)] INCLUDE ON THE SIGN A WARNING THAT READS "\$500 FINE" PURSUANT
17 TO THE CIVIL PENALTY IMPOSED BY SECTION 28-721.]
18 Sec. 2. Section 28-721, Arizona Revised Statutes, is amended to
19 read:
20 28-721. Driving on right side of roadway; civil penalty;
21 driving on shoulder; exceptions; education
22 A. On all roadways of sufficient width, a person shall drive a
23 vehicle on the right half of the roadway except as follows:
24 1. When overtaking and passing another vehicle proceeding in the
25 same direction under the rules governing the movement.
26 2. When the right half of a roadway is closed to traffic while
27 under construction or repair.

1 3. On a roadway divided into three marked lanes for traffic under
2 the rules applicable on the roadway.

3 4. On a roadway designated and signposted for one-way traffic.

4 B. On all roadways, a person driving a vehicle proceeding at less
5 than the normal speed of traffic at the time and place and under the
6 conditions then existing shall drive the vehicle in the right-hand lane
7 then available for traffic or as close as practicable to the right-hand
8 curb or edge of the roadway, except when overtaking and passing another
9 vehicle proceeding in the same direction or when preparing for a left turn
10 at an intersection or into a private road or driveway. THE DEPARTMENT AND
11 EACH LOCAL AUTHORITY SHALL PLACE SIGNS ON A HIGHWAY WITH TWO [OR MORE]
12 LANES FOR USE BY MOTOR VEHICLES TRAVELING IN THE SAME DIRECTION PURSUANT
13 TO SECTION 28-654. A PERSON WHO VIOLATES THIS SUBSECTION IS SUBJECT TO A
14 CIVIL PENALTY OF \$500.

15 C. In an age restricted community that is located in an
16 unincorporated area of a county with a population of more than three
17 million persons, a person may drive a golf cart or a neighborhood electric
18 vehicle on a paved shoulder that is adjacent to a roadway or as close as
19 practicable to the right-hand curb or edge of a paved roadway if there is
20 no delineated paved shoulder.

21 D. Defensive driving school courses that are offered by defensive
22 driving schools operated pursuant to chapter 8, article 7 of this title
23 and traffic survival schools operated pursuant to chapter 8, article 7.1
24 of this title shall include educational information relating to
25 subsections A and B of this section. The department shall include
26 information relating to subsections A and B of this section in any of the
27 department's examination, information and education materials.
