INTERSTATE 7 10 AND INTERSTATE 40 ON WHICH THERE ARE] TWO [OR MORE] LANES FOR USE BY 8 MOTOR VEHICLES TRAVELING IN THE SAME DIRECTION THAT DIRECT SLOWER TRAFFIC 9 TO TRAVEL IN A LANE OTHER THAN THE FARTHEST LEFT LANE. B. THE SIGN MUST: 10 1. READ "LEFT LANE FOR PASSING ONLY, SLOW TRAFFIC KEEP RIGHT." [THE 11 12 SIGN SHALL BE FORTY-EIGHT INCHES IN HEIGHT AND FORTY-EIGHT INCHES IN 13 WIDTH.7 14 2. [EITHER: 15 (a)] BE ACCOMPANIED BY A SMALLER SIGN THAT READS "[\$500] [\$200] 16 FINE" PURSUANT TO THE CIVIL PENALTY IMPOSED IN SECTION 28-721. 17 [(b) INCLUDE ON THE SIGN A WARNING THAT READS "\$200 FINE" PURSUANT 18 TO THE CIVIL PENALTY IMPOSED BY SECTION 28-721.] 19 Sec. 2. Section 28-721, Arizona Revised Statutes, is amended to 20 read: 21 28-721. Driving on right side of roadway; civil penalty; 22 driving on shoulder: exceptions: education 23 A. On all roadways of sufficient width, a person shall drive a 24 vehicle on the right half of the roadway except as follows: 25 1. When overtaking and passing another vehicle proceeding in the 26 same direction under the rules governing the movement.

1 2. When the right half of a roadway is closed to traffic while 2 under construction or repair.

3 3. On a roadway divided into three marked lanes for traffic under 4 the rules applicable on the roadway.

4. On a roadway designated and signposted for one-way traffic.

6 B. On all roadways, a person driving a vehicle proceeding at less 7 than the normal speed of traffic at the time and place and under the 8 conditions then existing shall drive the vehicle in the right-hand lane 9 then available for traffic or as close as practicable to the right-hand 10 curb or edge of the roadway, except when overtaking and passing another 11 vehicle proceeding in the same direction or when preparing for a left turn 12 at an intersection or into a private road or driveway. THE DEPARTMENT AND 13 EACH LOCAL AUTHORITY SHALL PLACE SIGNS [IN THIS STATE] ON [A HIGHWAY WITH] 14 [THE PORTIONS OF INTERSTATE 8, INTERSTATE 10 AND INTERSTATE 40 ON WHICH 15 THERE ARE] TWO [OR MORE] LANES FOR USE BY MOTOR VEHICLES TRAVELING IN THE 16 SAME DIRECTION PURSUANT TO SECTION 28-654. A PERSON WHO VIOLATES THIS 17 SUBSECTION IS SUBJECT TO A CIVIL PENALTY OF [\$500][\$200].

18 C. In an age restricted community that is located in an 19 unincorporated area of a county with a population of more than three 20 million persons, a person may drive a golf cart or a neighborhood electric 21 vehicle on a paved shoulder that is adjacent to a roadway or as close as 22 practicable to the right-hand curb or edge of a paved roadway if there is 23 no delineated paved shoulder.

D. Defensive driving school courses that are offered by defensive driving schools operated pursuant to chapter 8, article 7 of this title and traffic survival schools operated pursuant to chapter 8, article 7.1 of this title shall include educational information relating to subsections A and B of this section. The department shall include information relating to subsections A and B of this section in any of the department's examination, information and education materials.
