FLOOR AMENDMENT EXPLANATION

- 1. Requires the annual school safety report to contain data regarding the number of school safety incidents, referrals to law enforcement and school climate as reported to the U.S. Department of Education for the Civil Rights Data Collection survey (CRDC), rather than the number of incidents of specified types of physical attack reported at each Arizona school site.**
- 2. Specifies that each public school and local education agency (LEA) must post a link on its website to the most recent information reported to the U.S. Department of Education for the CRDC.**
- 3. Removes the requirement for the Arizona Department of Education (ADE) to establish a survey to gather information for the annual school safety report from each school district and charter school.**
- 4. Directs ADE to compile the outlined data from publicly available sources or the most recent information that a public school or LEA reported to the U.S. Department of Education for the CRDC.**

7 A. SUBJECT TO SUBSECTION B OF THIS SECTION, EACH PUBLIC SCHOOL AND
8 EACH LOCAL EDUCATION AGENCY SHALL POST ON ITS WEBSITE [A LINK TO] THE MOST
9 RECENT INFORMATION THAT THE PUBLIC SCHOOL OR LOCAL EDUCATION AGENCY
10 REPORTED TO THE UNITED STATES DEPARTMENT OF EDUCATION OFFICE FOR CIVIL
11 RIGHTS FOR THE PURPOSES OF THE CIVIL RIGHTS DATA COLLECTION SURVEY.

12 B. THIS SECTION DOES NOT AUTHORIZE A PUBLIC SCHOOL OR LOCAL
13 EDUCATION AGENCY TO PUBLISH DATA THAT IS PROTECTED UNDER THE FAMILY
14 EDUCATIONAL RIGHTS AND PRIVACY ACT OF 1974 (P.L. 93-380; 88 STAT. 571; 20
15 UNITED STATES CODE SECTION 1232g). A PUBLIC SCHOOL OR LOCAL EDUCATION
16 AGENCY THAT POSTS INFORMATION ON ITS WEBSITE PURSUANT TO SUBSECTION A OF
17 THIS SECTION SHALL REDACT THE INFORMATION TO ENSURE THAT IT COMPLIES WITH

23 A. ON OR BEFORE DECEMBER 15 OF EACH YEAR, THE DEPARTMENT OF
24 EDUCATION SHALL SUBMIT A SCHOOL SAFETY REPORT TO THE GOVERNOR, THE
25 PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES
26 AND PROVIDE A COPY OF THE REPORT TO THE SECRETARY OF STATE. THE REPORT

17 FOR THE REPORT FROM EACH SCHOOL DISTRICT AND CHARTER SCHOOL. A SCHOOL
18 DISTRICT OR CHARTER SCHOOL MAY NOT REPORT PERSONALLY IDENTIFIABLE STUDENT
19 DATA] [COLLECT THE INFORMATION FOR THE REPORT REQUIRED BY SUBSECTION A OF
20 THIS SECTION FROM PUBLICLY AVAILABLE SOURCES AND THE MOST RECENT
21 INFORMATION THAT EACH PUBLIC SCHOOL REPORTED TO THE UNITED STATES
22 DEPARTMENT OF EDUCATION OFFICE FOR CIVIL RIGHTS].
23 C. THE REPORT SHALL BE POSTED ON THE DEPARTMENT'S WEBSITE IN A
24 FORMAT THAT IS ACCESSIBLE TO THE PUBLIC.
