Biasiucci Floor Amendment

-
1. Incorporates the changes included in the amendment adopted by the Committee on Education.
 2. Applies the prohibition on a school serving, selling or allowing a third party to sell ultraprocessed food on the school campus during the normal school day:
 - a) beginning in the 2026-2027 school year; and
 - b) to any school that participates in any federally funded or assisted meal program.

18 DEPARTMENT THAT THE PUBLIC SCHOOL IS COMPLYING WITH THE REQUIREMENTS

20 C. FOR THE PURPOSES OF THIS SECTION, "ULTRAPROCESSED FOOD" MEANS A
21 FOOD OR BEVERAGE THAT CONTAINS ONE OR MORE OF THE FOLLOWING INGREDIENTS:

- 22 1. POTASSIUM BROMATE.
- 23 2. PROPYLPARABEN.
- 24 3. TITANIUM DIOXIDE.
- 25 4. BROMINATED VEGETABLE OIL.
- 26 5. YELLOW DYE 5.
- 27 6. YELLOW DYE 6.

1 7. BLUE DYE 1.
2 8. BLUE DYE 2.
3 9. GREEN DYE 3.
4 10. RED DYE 3.
5 11. RED DYE 40.
6 Sec. 2. Legislative findings
7 The legislature finds that:
8 1. Childhood obesity, morbidity and wellness are matters of
9 statewide concern.
10 2. Ultraprocessed, industrially manufactured, nutrient-depleted
11 food with synthetic additives is undernourishing minors at public schools
12 and contributing to childhood obesity.
13 3. Any taxpayer-funded meal or snack program offered to minors at
14 public schools in this state should be nutritious and made primarily of
15 whole, minimally processed plant or animal products.
