1 The resolution as proposed to be amended is reprinted as follows:

2       1. Article IX, Constitution of Arizona, is proposed to be amended

3 by adding section 26 as follows if approved by the voters and on

4 proclamation of the Governor:

5           26. Vehicle miles traveled: taxing, monitoring and  
6                   limiting prohibited: exception

7           SECTION 26. A. THIS STATE AND ANY COUNTY, CITY, TOWN,

8 MUNICIPAL CORPORATION OR OTHER POLITICAL SUBDIVISION OF THIS

9 STATE MAY NOT DO EITHER OF THE FOLLOWING:

10           1. IMPOSE A TAX OR FEE ON ANY PERSON BASED ON THE

11 VEHICLE MILES TRAVELED BY THE PERSON IN A MOTOR VEHICLE.

12           2. ENACT ANY RULE OR LAW TO MONITOR OR LIMIT THE

13 VEHICLE MILES TRAVELED BY A PERSON IN A MOTOR VEHICLE UNLESS

14 THE RULE OR LAW REQUIRES THAT THE PERSON VOLUNTARILY CONSENTS

15 TO THE MONITORING OR LIMITATION.

16           B. THIS SECTION DOES NOT APPLY TO [EITHER OF THE

17 FOLLOWING:

1           1.] AN INTERSTATE AGREEMENT THAT IS ESTABLISHED TO  
2       ADMINISTER THE PAYMENT OR REPORTING OF FUEL TAXES OR  
3       REGISTRATION FEES FOR COMMERCIAL VEHICLES THAT OPERATE IN MORE  
4       THAN ONE STATE.

5           [2. A MOTOR VEHICLE OWNED AND OPERATED BY ANY ENTITY  
6       LISTED IN SUBSECTION A OF THIS SECTION.]

7       2. The Secretary of State shall submit this proposition to the  
8 voters at the next general election as provided by article XXI,  
9 Constitution of Arizona.

11 Amend title to conform
