1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 28, chapter 2, article 5, Arizona Revised
3 Statutes, is amended by adding section 28-459, to read:

4 28-459. Voluntary customer records; law enforcement
5 disclosure; definitions

6 A. A PERSON WITH A DRIVER LICENSE OR NONOPERATING IDENTIFICATION
7 LICENSE ISSUED BY THE DEPARTMENT MAY REQUEST THAT THE DEPARTMENT NOTE IN
8 THE DEPARTMENT'S CUSTOMER RECORD THAT THE PERSON MAY NEED A COMMUNICATION
9 ACCOMMODATION.

10 B. THE OWNER OF A VEHICLE REGISTERED IN THIS STATE MAY REQUEST THAT
11 THE DEPARTMENT NOTE IN THE DEPARTMENT'S VEHICLE RECORD THAT THERE MAY BE AN
12 OCCUPANT OF THE VEHICLE THAT MAY NEED A COMMUNICATION ACCOMMODATION.

13 C. THE REQUEST SHALL BE MADE IN A METHOD DETERMINED BY THE
14 DEPARTMENT.

15 D. THE DEPARTMENT SHALL ESTABLISH PROCEDURES TO MAKE THE NOTATIONS
16 AVAILABLE ONLY TO LAW ENFORCEMENT AGENCIES.

17 E. FOR THE PURPOSES OF THIS SECTION:

18 1. "COMMUNICATION ACCOMMODATION" MEANS THAT A PERSON HAS A
19 DISABILITY THAT CAN IMPAIR COMMUNICATION AND THE PERSON MAY REQUIRE AN
20 ACCOMMODATION.

21 2. "DISABILITY THAT CAN IMPAIR COMMUNICATION" MEANS A CONDITION THAT
22 CAN IMPAIR A PERSON'S ABILITY TO RECEIVE, SEND, PROCESS OR COMPREHEND
23 CONCEPTS OF VERBAL OR NONVERBAL COMMUNICATION OR GRAPHIC SYMBOLS."
