FLOOR AMENDMENT EXPLANATION

- 1. Specifies that a municipality or county may not enact any ordinance, rule or regulation that restrict or prohibits general construction activities during certain hours between May 1 and October 15 of each year, rather than between May 1 and September 31 of each year.**
- 2. Adds the hours of between 7:00 AM and 7:00 PM on Saturdays to the prescribed time periods a municipality or county is prohibited from enacting an ordinance, rule or regulation that restricts general construction activities during the summertime period.**
- 3. Adds an emergency clause.**

22 ~~[SEPTEMBER 31]~~[OCTOBER 15] OF EACH YEAR BETWEEN THE HOURS OF 5:00 A.M. AND
23 7:00 P.M. EACH BUSINESS DAY [AND BETWEEN THE HOURS OF 7:00 A.M. AND 7:00
24 P.M. ON SATURDAY] IF THE CONSTRUCTION WORK IS BEING PERFORMED PURSUANT TO
25 A VALIDLY ISSUED BUILDING PERMIT ISSUED BY THE COUNTY.

26 B. THE COUNTY SHALL ALLOW CONCRETE TO BE POURED AT LEAST ONE HOUR
27 BEFORE THE TIME THAT GENERAL CONSTRUCTION ACTIVITIES ARE REGULARLY
