3 The bill as proposed to be amended is reprinted as follows:  
4 Section 1. Appropriation; department of veterans' services;  
5 mental and behavioral health; exemption  
6 A. The sum of \$1,000,000 is appropriated from the [consumer  
7 remediation subaccount of the consumer restitution and remediation  
8 revolving fund established by section 44-1531.02, Arizona Revised  
9 Statutes,] [state general fund] in fiscal year 2025-2026 to the department  
10 of veterans' services for grants to nonprofit organizations that deliver  
11 evidence-based, trauma informed, clinical care, physical fitness and  
12 strength conditioning training from a certified strength and conditioning  
13 specialist, mindful movement classes, nutritional guidance from a  
14 registered dietician, wellness, education, peer outreach, programming for  
15 Native American veterans, and clinician training for the benefit of active  
16 duty service members, veterans of all eras and discharge status, and their  
17 families, who are impacted by mental and behavioral health issues,  
18 including any of the following:  
19 1. Post-traumatic stress injuries.  
20 2. Traumatic brain injuries.  
21 3. Depression.  
22 4. Anxiety.  
23 5. Substance use disorder.  
24 6. Suicidal ideation.  
25 B. Nonprofit organizations shall administer the services described  
26 in subsection A of this section in partnership with qualified hospital  
27 systems within this state and state universities, regardless of the dates  
28 the veterans or active duty service members served in the military or were  
29 discharged or separated from service.

1 C. The appropriation made in subsection A of this section is exempt  
2 from the provisions of section 35-190, Arizona Revised Statutes, relating  
3 to lapsing of appropriations.
