FLOOR AMENDMENT EXPLANATION

- Applies the prescribed exceptions for probationers who participate in a recognized apprenticeship program to probationers on standard probation, rather than all types of supervised probation.
- Specifies that a probationer's travel outside of the probationer's jurisdiction to work in the apprenticeship program must be within Arizona.
- Removes the stipulation that the probationer return to the jurisdiction in which they reside by 11:59 p.m. each day in order to receive the outlined travel exception.
- Makes a technical change.

1 The bill as proposed to be amended is reprinted as follows:

2 Section 1. Title 13, chapter 9, Arizona Revised Statutes, is 3 amended by adding section 13-912, to read:

4 13-912. <u>Apprenticeship programs; hours; location</u>

5 A PROBATIONER WHO IS ON [SUPERVISED] [STANDARD] PROBATION AND WHO IS 6 PARTICIPATING IN A STATE OR FEDERALLY RECOGNIZED APPRENTICESHIP PROGRAM 7 MAY DO BOTH OF THE FOLLOWING:

8 1. WORK AT ANY HOURS OF THE DAY AS LONG AS THE PROBATIONER REMAINS 9 IN GOOD STANDING WITH THE APPRENTICESHIP PROGRAM.

10 2. TRAVEL [<u>WITHIN THIS STATE</u>] OUTSIDE [<u>OF</u>] THE JURISDICTION IN 11 WHICH THE PROBATIONER RESIDES TO WORK IN THE APPRENTICESHIP PROGRAM [IF 12 THE PROBATIONER RETURNS TO THE JURISDICTION IN WHICH THE PROBATIONER 13 RESIDES BY 11:59 P.M. EACH DAY].

14 Enroll and engross to conform

15 Amend title to conform
