2 Section 1. Title 20, chapter 2, article [1] [6], Arizona Revised

3 Statutes, is amended by adding section [20-243] [20-466.06], to read:

4 [20-243.] [20-466.06.] Health care providers; property

5 insurers; casualty insurers; excessive health care

6 claims; notification; definitions

7 A. IF A HEALTH INSURER NOTICES A TREND IN THE NUMBER OF HEALTH CARE

8 INSURANCE CLAIMS THAT ARE FILED BY A HEALTH CARE PROVIDER FOR SERVICES

9 PROVIDED TO PATIENTS ON ANY GIVEN WORKDAY EXCEEDS THE NUMBER OF PATIENTS

10 THAT THE HEALTH CARE PROVIDER COULD REASONABLY BE EXPECTED TO TREAT ON

11 THAT GIVEN WORKDAY, THE HEALTH INSURER SHALL NOTIFY THE DEPARTMENT AND THE

12 BOARD THAT LICENSES, REGISTERS OR CERTIFIES THE HEALTH CARE PROVIDER.

13 [B. IF A PROPERTY OR CASUALTY INSURER NOTICES CLAIMS ACTIVITIES

14 THAT SUGGEST POSSIBLE INSURANCE OR HEALTH CARE FRAUD, THE PROPERTY OR

15 CASUALTY INSURER SHALL NOTIFY THE DEPARTMENT AND THE APPLICABLE BOARD THAT

16 LICENSES, REGISTERS OR CERTIFIES THE HEALTH CARE PROVIDER.]

17 [B.] [C.] FOR THE PURPOSES OF THIS SECTION:

18 1. "HEALTH CARE PROVIDER" MEANS A PERSON WHO IS LICENSED,

19 REGISTERED OR CERTIFIED AS A HEALTH CARE PROFESSIONAL UNDER TITLE 32.

20 2. "HEALTH INSURER" MEANS A DISABILITY INSURER, GROUP DISABILITY

21 INSURER, BLANKET DISABILITY INSURER, HEALTH CARE SERVICES ORGANIZATION,

22 HOSPITAL SERVICE CORPORATION OR MEDICAL SERVICE CORPORATION.

23 Enroll and engross to conform

24 Amend title to conform
