FLOOR AMENDMENT EXPLANATION

1. Requires the Arizona Department of Transportation to:
 - a) issue a class D or M license, rather than an expedited class D, G or M license; and
 - b) waive any written or driving examination requirements for an eligible active-duty member of the armed forces of a foreign country.
2. Requires a driver license issued to a member of foreign armed forces to expire on the same date as the expiration of the document authorizing the member to be in the United States.
3. Requires the foreign country to be a member of the North Atlantic Treaty Organization, rather than a signatory to an international security alliance that recognizes reciprocal driver permits or licenses.
4. Removes requiring the member of a foreign armed forces to possess a valid driver license issued by a foreign country that has substantially similar motor vehicle laws and regulations as Arizona.
5. Makes conforming changes.

2 Section 1. Section 28-413, Arizona Revised Statutes, is amended to

7 A. The department may waive the requirements for a written
8 examination and the driving examination required pursuant to section
9 28-3164 for an operator of a motor vehicle who holds a valid driver
10 license issued by a foreign country in which the operator previously
11 resided and who applies for an initial driver license in this state as an
12 original applicant, if all of the following conditions are met:
13 1. The director determines that the standards of the foreign
14 country for licensing operators of motor vehicles are substantially
15 similar to those of this state.
16 2. The foreign country extends the same reciprocal driver license
17 application privileges to persons licensed in this state.
18 3. The director and the foreign country have exchanged letters or
19 other documentation to confirm the reciprocal extension of privileges to
20 operate motor vehicles.
21 4. The original applicant under this section complies with the
22 mandatory motor vehicle insurance provisions of chapter 9, articles 1 and
23 4 of this title.
24 B. A person who holds a valid driver license that meets the
25 requirements of subsection A of this section may apply to the department
26 for a class D, G or M license. The person applying for the original
27 license shall present the foreign country driver license to the department
28 on successful application.

1 C. The department shall publish on its public website a current
2 list of foreign countries for which reciprocal operating privileges have
3 been extended and withdrawn.

23 IMMIGRATION AUTHORIZING THE ACTIVE DUTY MEMBER TO BE IN THE UNITED STATES.
