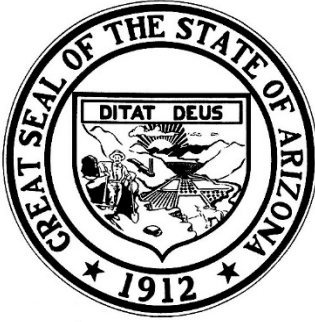

FLOOR AMENDMENT EXPLANATION

- 1. Requires a Department of Child Safety (DCS) caseworker to present identification when visiting a child at the child's school for the purposes of an interview, rather than when visiting a child who is in the care, custody and control of DCS at the child's school.**
- 2. Requires, if a DCS caseworker denies or is unable to provide the required forms of identification to the school:**
 - a) the DCS caseworker to provide the school with the contact information for the DCS office where the DCS caseworker is employed; and**
 - b) the school to contact the DCS office and verify the DCS caseworker's identification and employment.**
- 3. Makes conforming changes.**
