FLOOR AMENDMENT EXPLANATION

- Specifies that a school district or charter school is not required to develop and adopt the policies or procedures that govern student access to school-provided internet and limit use of wireless communication devices if the school district or charter school has existing policies or procedures that meet the prescribed requirements on the effective date.

2 Section 1. Title 15, chapter 1, article 1, Arizona Revised
3 Statutes, is amended by adding section 15-120.05, to read:
4 15-120.05. Student access to internet; student use of
5 wireless communication devices; policies and
6 procedures; definitions
7 A. EACH SCHOOL DISTRICT GOVERNING BOARD AND CHARTER SCHOOL
8 GOVERNING BODY SHALL PRESCRIBE AND ENFORCE POLICIES AND PROCEDURES THAT
9 BOTH:
10 1. GOVERN STUDENT ACCESS TO THE INTERNET AS PROVIDED BY THE SCHOOL,
11 INCLUDING POLICIES THAT RESTRICT STUDENT ACCESS TO SOCIAL MEDIA PLATFORMS.
12 THE POLICIES AND PROCEDURES ADOPTED PURSUANT TO THIS PARAGRAPH SHALL ALLOW
13 TEACHERS TO GIVE STUDENTS ACCESS TO SOCIAL MEDIA PLATFORMS TO THE EXTENT
14 NECESSARY FOR EDUCATIONAL PURPOSES.
15 2. LIMIT THE USE OF WIRELESS COMMUNICATION DEVICES BY STUDENTS
16 DURING THE SCHOOL DAY. THE POLICIES AND PROCEDURES ADOPTED PURSUANT TO
17 THIS PARAGRAPH SHALL ALLOW STUDENTS TO USE WIRELESS COMMUNICATION DEVICES
18 FOR EDUCATIONAL PURPOSES, AS DIRECTED BY THE STUDENT'S TEACHER, OR DURING
19 AN EMERGENCY.
20 B. FOR THE PURPOSES OF THIS SECTION:
21 1. "SCHOOL DAY" MEANS PERIODS OF TIME WHEN STUDENTS ARE AT SCHOOL,
22 INCLUDING MEALS, PASSING PERIODS AND RECESS.
23 2. "SOCIAL MEDIA PLATFORM" MEANS A WEBSITE, COMPUTER APPLICATION OR
24 OTHER DIGITAL PLATFORM THAT IS USED FOR SOCIAL NETWORKING AND CREATING OR
25 EXCHANGING VIRTUAL CONTENT.
26 3. "WIRELESS COMMUNICATION DEVICES" INCLUDES PERSONAL DEVICES AND
27 DEVICES THAT ARE PROVIDED BY THE SCHOOL.
